## Missoula County Commissioners Seek Applicants for Fire Districts, Advisory Boards

---

[Missoula Rural Fire District](#), [Seeley Lake Rural Fire District](#) and [Swan Valley Fire Service Area](#) each have one vacant term that runs through May 31, 2022. All applicants must live within specific fire district boundaries. At the end of the term, if the commissioner-appointed members wish to continue serving, they must file as a candidate in the school/special district election of 2022. Fire district board of trustees govern and provide guiding leadership, policy and funding oversight.

The [Tom Green Memorial Park Advisory Group](#) has three seats open to new applicants. One vacant term runs through June 30, 2022, and two three-year terms run through June 30, 2020. Current members who wish to continue serving must submit a letter or email of interest to the commissioners. Applicants must reside within the boundaries of [RSID 902](#).

The Tom Green Memorial Park Advisory Group advocates for the overall welfare of Tom Green Memorial Park through review of current issues, recommendations to the Missoula County Parks and Trails Advisory Board and hands-on stewardship of the land. The advisory group meets each March and September and typically one other time during the summer.

### Additional boards with vacant terms (open until filled):

[Bonner-Milltown Community Council](#) has one vacant partial term running to May 31, 2021.

[Evaro-Finley-O'Keefe Community Council](#) has one vacant three-year term running through May 31, 2022.

[Fair Event Committee](#) has one vacant alternate member term. The new member will fill the remainder of a three-year term running through Sept. 30, 2021.

[Lolo Mosquito Abatement Board](#) has one vacant term. The new member will fill the remainder of a three-year term running through Dec. 31, 2021.

[Missoula Development Authority Technology District Advisory Board](#) has a vacant three-year term through June 20, 2022.

[Planning and Zoning Commission](#) has one vacant term. The new member will fill the remainder of a two-year term running through Dec. 31, 2019. Applicants must live within the boundaries of a [citizen-initiated planning and zoning district](#).

[Weed Control Board](#) has two alternate three-year terms that run through Dec. 31, 2021.
